

Limited Warranty

Fabtek Aero, Ltd., hereinafter referred to as "FABTEK AERO, LTD.", warrants for the period of 12 months from the date of shipment, unless otherwise stated below, (the "Warranty Period"), that the "Products" manufactured by it will be free from defects in material and workmanship.

FABTEK AERO, LTD. will correct defects in material or workmanship, which may develop in its products under proper and normal use during the Warranty Period and under the conditions of this Warranty. This Warranty does not extend to anyone except the original consumer-purchaser. Damage to the product due to improper handling, storage, maintenance, application, or installation is not covered by this Warranty. Warranty claims for motors, special items, or accessories not manufactured by FABTEK AERO, LTD. should be directed to those who manufactured the item. FABTEK AERO, LTD. will repair or replace, at its option and expense, its products proved to be defective after examination by an authorized representative of FABTEK AERO, LTD. The defective Product must be returned, transportation prepaid, to the factory at Plano, Illinois, USA. Disassembly of the equipment (especially pumps) impairs determination of reasons for failure and shall be cause for voiding this Warranty. The Product, repaired or replaced, will be shipped F.O.B. FABTEK AERO, LTD.'s factory. This is FABTEK AERO, LTD.'s sole warranty. FABTEK AERO, LTD. makes no other warranty of any kind, express or implied, and all implied warranties of merchantability and fitness for a particular purpose which exceed FABTEK AERO, LTD.'s aforestated obligations are hereby disclaimed by FABTEK AERO, LTD. and excluded from this warranty. FABTEK AERO, LTD. neither assumes nor authorizes any person to assume for it, any other obligation in connection with the sale of the Product and any enlargement of this Warranty by a purchaser shall be for its own account and its exclusive responsibility. This Warranty shall not apply to any Product or parts of Products which: (a) have been repaired or altered outside of FABTEK AERO. LTD.'s factory, in any manner; or (b) have been subjected to misuse, negligence or accident; or (c) have been used in a manner inconsistent with FABTEK AERO, LTD.'s printed instructions, specifications, or the customer supplied application specification; or (d) have been damaged due to defective power supply or faulty installation. FABTEK AERO, LTD. shall not be liable for incidental and consequential losses and damages under this express warranty, any applicable implied warranty, or claims for negligence, except to the extent that this limitation is found to be unenforceable under the applicable State law. Some States do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. This warranty gives you specific legal rights, and you may also have other rights, which vary from State to State.

All requests for warranty claims should be made through the company from which the product was purchased or supplied.
